As Managing Director, Lenz managed relationships and programs that serve NCSEA's membership, developed staff abilities, supported new technology markets, and increased business opportunities for the organization. Lenz has been working in clean energy since the early 1990's, including serving as North Carolina's State Energy Office Director under Governors Perdue and McCrory and Chair of the Association of State Energy Research and Technology Transfer Institutions. Lenz is experienced, trusted, and supported by NCSEA team, and his dedication to our clean energy economy is indisputable.

NCSEA's Board has been deeply engaged throughout this process. Incoming Board Chair Cris Masselle, who is in her seventh year of service added, "Together in their new roles, Urlaub and Lenz are poised to firmly establish NCSEA as a leader in North Carolina's most substantive energy policy, regulatory, and market transformation in our state since the 1960's and to diversify and strengthen the coalition of clean energy supporters NCSEA has partnered with in our 42-year history."
